- Class 3B - Spouse associate-weekdays, Saturday after 12:30PM and Sundays & holidays after 12:00PM
- Class 4 - Adult associate – Golf privileges weekdays only (excludes holidays)
- Class 5A - 5C Intermediates – weekdays, Saturday after 12:30PM and Sundays & holidays after 12:00PM
 * 5A Ages 25 - 29 - Ref graduated detailed plan by year
 5B Ages 18 – 24 Parent is not a member of the club
 5C Ages 18 – 24 Parent is a member of the club
- Class 6 - Juniors, ages 12-17 - discretion of Pro Shop
- Class 7 - Social – single/family (includes 8 nine hole rounds or 4 eighteen hole rounds weekdays only)
- Class 8 - Honorary
- Class 9 - Corporate
